Most of the people are workers and or laborers, not having a fixed long-term job.

The houses are made of adobe or bricks but the roof is made of corrugated iron.

Farming is a key resource for families. But the income depends on the rains. So depending on the season population have the opportunity to work. The main assets are the people, they are ready to work and to overcome difficulties.

- g. In two sentences or more, please describe why a church is needed here:

The first reason is because of the spiritual need in families of the community, the ignorance of most people about God and His word. There is not any church around this area, ours is being the first church to be founded in Castilla. By the other there are absence of basic services like water, sewage and electricity. And there are problems with drug addiction and alcoholism.

No, there are no other churches in "Castilla" near the church, there are other groups but they do not have good doctrine.
